Tenders will be opened online in the presence of such tenderers or their authorized representatives who have logged in, on their own, before the prescribed time of opening of technical & financial bids. If the date fixed for opening happens to be a holiday/unable to open the tender due to technical issues, the tenders will be opened in the next working day, at the same time.

The tenderer, or his representative, shall be physically present at the Fire and Rescue Services Headquarters on the date prescribed, with the necessary documents and presentations on all the technical aspects of the equipment and accessories for the total understanding and verification of the technical committee. The firms shall give in writing any aspect of the Appliance, if asked

by the evaluation committee during the presentation. The offer of any firm, which fails to represent in the presentation and evaluation in the prescribed date and time, or fails to give complete details of the proposed Appliance including accessories during presentation, will be rejected.

The tender fee and EMD shall be received only through online payment SBI/SBI NEFT.

The cost should be quoted in Indian currency only.

The first cover ie: the technical cover shall be uploaded with the following documents.

TECHNICAL SPECIFICATION OF MAPS, CHARTS AND COMPASS

1) MAPS

Navigation maps are required for every district in Kerala except Kottayam.

Four numbers of navigation maps are required for each district. A sub total of 52(13Districts×4) is needed.

II) CHARTS (52 NOS)

Nautical chart which depicts the configuration of the shoreline and seafloor shall be provided. It shall provide water depths, location of dangers to navigation, locations and characteristics of aids to navigation, anchorages and other features for navigation.

III) COMPASS (52 NOS)

Magnetic compass for navigation shall be provided.

Dial Diameter - Not less than 65 mm.

Dial graduation-0 to 360 Degree (5 degree per grid)

Weight shall not be more than 1 Kg.

Sample should be submitted at the time of technical evaluation.
